- You may bring a table and/ or tent to set up at south end of the arena if you wish to sell tack

- **Use of school horse plus coaching available - Fee: \$20**

From Springfield: Take Hwy 65 South.-Exit at Hwy F/South St./Sparta (last Ozark Exit). Turn right (west). Go 1.5 miles to new bridge. Turn left into our driveway immediately after bridge. Proceed left then turn right through the narrow gate (be careful)

From Branson: Take Hwy 65 North. Exit at Hwy F/South St/Sparta (first Ozark exit). Turn left (west). Go 1.5 miles to new bridge. Turn left into our driveway immediately after bridge. Proceed left then turn right through the narrow gate (be careful).
