Points for the first show will count, however you must nominate ON or BEFORE the second show. If you miss any shows, you miss a chance to get points. High point totals are NOT PRORATED.
- 3) POINTS are as follows: 1st place gets 6 points, 2nd place gets 5 points, 3rd place gets 4 points, 4th place gets 3 points, 5th place gets 2 points & 6th place gets 1 point.
- 4) No required number of entries in classes in order to receive points.
- 5) No refunds once you sign up for this program.
- 6) You must fill out an awards form & pay your fee in order to get into this program.
- 7) In case of a tie in points-most blue ribbons won, or number of shows attended will determine the winner
