4. To be eligible for the Highpoint All Around you must show in a halter class.

Permanent or Portable Stalls are \$ 115.00 each.

***Please remember that after all permanent stalls are filled that you will have to stall in portable stalls.***

## No Refunds/No Exceptions

- All stalls must be reserved for this show.
- All horses must have stalls, Except with prior notes
- No reservations can be made without payment.
- All reservations and payments must be through Show manager.
- Stalls are assigned on a first come first paid basis.
- Attempts will be made to stall persons and barns together as a courtesy; a list of each person requiring a stall in the group is required for stalling together.
- Have name and number of stalls per person and per group in total.
- If payment made by farm or single check, the farm will be responsible for collecting monies from individuals.
- Preferences will only be made for those persons who have paid.
- Stalls are not transferable without the consent of show management.
- Any stall used as a kennel or tack stall is charged at the same rates outlined above.

## SHAVINGS

- Shavings will be delivered between 8:00 A.M.. - 5:00 P.M. (352-472-6758)
- Shavings will only be delivered if paid in advance.

## PETS, ETC

- All pets must be on a leash or crated. Loose dogs will be assessed a fine of \$50 per incident.
- The Canterbury Show Place or DPHC will not be held liable for compensation if a pet is removed from the show facility at the request of management.
- Pets include but are not limited to dogs, cats, goats, birds etc.

**Motor Vehicles**

- No person without a valid driver's license, under age 18 may operate a four wheeler or motorcycle on the show grounds.

*All futurity class entries must be USPS postmarked on/by November 10<sup>th</sup> 2005, any entries postmarked after November 10th will pay a late fee rate. If registration is not received by November 10<sup>th</sup> fees will be doubled, up to class time. Only cash will be accepted as payment for registration at the show for futurity classes. No pre-assigned back numbers. Show secretary will issue all numbers.*

**There will be NO exceptions to these rules.**

- There are NO Refunds and NO Exceptions for Futurity Classes and/or stalls.
- All added classes must be done in the office at least three classes before. There are NO adds at the gate.
- To receive refunds for dropped APHA classes, the OFFICE must be notified 3 classes in advance.
- Drops may be accepted at the gate (No refunds).
- Exhibitor will be charged full fee for all drops at the gate.
- All scratches or no shows will be charged full fee for classes missed.
- Entries must be on the official Dixie Paint Horse Club Forms
- All horses must be entered under legal name of OWNER and must have legal owner's complete address.
- All horses must be entered under its registered name and number.
- All entries must have a copy of papers (All breeds).
- All horses on grounds must have a legal copy of Coggins test
- All non-pro/amateur/novice entrants must have a valid non-pro/amateur/novice card.
- Show Management reserves the right to cancel any class.

**MEMBERSHIP**

- **Owners and Exhibitors must be a DPHC member to show in ALL Futurity Classes**
- Memberships may be purchased at the show.
- All memberships expire on December 31 in the year, which paid.
- Individual membership are available for \$25.00
- Family Memberships are available for \$35.00
- Farm Memberships are available for \$35.00

## **GRIEVANCES**

Should a situation arise for contesting a decision or rule, a \$100 fee must be paid up front to the Dixie Paint Horse Club. The \$100 fee must be accompanied by a written complaint or grievance. The grievance will then be forwarded to the grievance committee whose decision is final. However, due to the nature of this show, a decision may be made after the show's conclusion.

**All** judges decisions on classes are final

**All** decisions made by show management are final.

**All** decisions made by the Grievance Committee are final.

## **CIRCUIT AWARDS**

Youth, Novice and Amateur will show to all eight judges for eligibility towards circuit awards.

Open will show to four judges for eligibility towards circuit awards. There must be 3 horses in class each day to receive circuit award.

## **BARN CALLS**

Barn calls are a courtesy to exhibitors.

- THERE WILL BE NO REFUND FOR MISSED CLASSES AND
- THERE WILL BE NO EXCEPTIONS TO THIS RULE.
- A maximum of 5 minutes will be given after the first horse enters the ring after which the gate will be closed.
- All tack changes must be scheduled with the Gatekeeper/Ring Manager.

## **ARRIVAL**

Stall assignments will be available at the stalls upon arrival. You must check in with Ed Cox for your stall assignment.

## **HEALTH REGULATIONS**

Florida residents are required to submit an original Negative Coggins Test that is less than 12 months old.

Out of state exhibitors must submit a Negative Coggins Test record with test results less than 12 months old AND a Health Certificate signed by a veterinarian within the last 31 days.

## **DRUG TESTING**

An official drug inspector has been requested from APHA. Should your horse be chosen for testing, you must comply with the drug tester's request or forfeit all placings, awards and membership to the Dixie Paint Horse Club.

## **DISCIPLINE**

Show management will be charged with the responsibility of enforcing all APHA, DPHC and NSBA rules. The management reserves the right to remove a groom, horse, rider, or driver from the show without being liable for compensation or damages.

Exhibitors are warned that any act of discourtesy by owner, groom, rider, or driver will disqualify them from future class participation at the Florida Fall Classic.

The Show Management also bears the responsibility to aid the judges in avoiding contact with exhibitors or agents before and during the show. Any offensive or abusive contact with the judge by any exhibitor will be just cause for immediate removal from the grounds.

## **RESPONSIBILITY**

Canterbury Show Place and The Dixie Paint Horse Club, and Dixie Paint Horse Club Stallion Breeders, their officials, employees, and volunteers, will not be responsible for any death, accident, loss, damage or injury which may occur to be suffered by an exhibitor, guest, rider, groom, attendant or any other individual on the grounds during this show NOR will they be responsible for any article which may be lost, destroyed or stolen whether or not such loss, damage or injury is the result of negligence of the show of the committee or their respective, agents or employees.

**PAYOUTS**

**All payouts will be made at the end of the show.**

**Checks will only be made payable in the name of the owner. No exceptions. In the event the full owner’s name and address has not been correctly completed on the form, the owner must notify DPHC in writing within 60 days of the show with the information to receive payment. DPHC or DPHCSB will not be responsible for any futurity checks with incorrect addresses after the 60 days.**

**FUTURITY QUALIFICATIONS and REQUIREMENTS**

- To show in any Breeders futurity class, the entry must be the get of one of the listed sires.
- **Owners and Exhibitors must be a DPHC member to show in ALL Futurity Classes**
- *Breeding stock horses may show in all eligible futurities through their 2 year old year.*
  - Senior Weanling classes = January 1 through March 31 foaling dates
  - Junior Weanling classes = All foals April 1 or later foaling date.
  - Florida Bred – Foals are eligible to show in the Florida Bred Program when:
    1. **Foal was born in Florida as shown on Registration (AND)**
    2. **Must be owned by Florida resident with drivers license. (AND)**
    3. **Must be shown by a Florida resident. Proof of residency required.**
  - A buy-in of a stallion is \$700.00 (seven hundred dollars) - 6/1/2005 to 9/1/2005
  - No buy-in of stallion after 9/1/2005, **NO EXCEPTIONS.**
  - No refunds on buy-ins.
  - All other Breeders rules apply for the stallion bought in.

All Horses entered in classes at the futurity MUST be of regular registry of the APHA or AQHA or get of nominated stallions and proof of registration must be shown at the time of entry. Breeding Stocks are eligible for some futurities.

All horses must have registration papers, **NO EXCEPTIONS.**

All Amateur/Novice will show under APHA rules requiring a 2005 Amateur/Novice Card, must have card at time of registration.

All payouts are based on **75%** of entry fees + **100%** of added monies **(if 3 or more in a class).**

There **must be at least three entries to receive the full amount of added money.** Less than three entries will result in ½ amount of total purse times applied percentage.

# DIXIE PAINT HORSE CLUB BREEDERS FUTURITY RULES

- 1A. Donated Breeding with Sale of Breeding-Stallion *owner* agrees to donate one breeding to his/her stallion to the Dixie Paint Horse Club Stallion Breeders (DPHCSB) Futurity, to be sold for the next breeding season. When this breeding is sold, all get from the stallion will be eligible to enter the DPHCSB Futurity classes the following year.
- 1B. Stallion Buy-in Program - Stallion owners whose stallion breeding does not sell have the option to buy-in their stallion making all get eligible for the following year futurity at \$350 on or before the June 1 deadline and \$700 from June 2 thru September 1. No breedings or buy-ins will be sold after the September 1<sup>st</sup> deadline. No exceptions.
- 1C. No Stallion Substitutions - A breeding must be donated and sold by the same stallion for the next breeding season so as to have the participating stallion's foal crop eligible for the following year's DPHCSB Futurity.
- 1D. Stallion Contracts/Futurity Qualifications-All stallion nomination fees must be paid prior to the Sept. 1, deadline for get to be eligible for the current year's futurity. All signed stallion nomination contracts with DPHCSB must be in the DPHCSB's possession by 12, midnight, September 1.
2. If a stallion dies after his service is sold and the mare is bred and settled and loses her foal or has never been success fully bred, the following rules apply:
- A. The breeding contract between the mare owner and the stallion owner will apply.
  - B. The mare owner of the purchased breeding will either choose another stallion breeding for the current year, and pay any additional fees or receive a full refund.
  - C. If the replacing stallion's fee is more than the replaced stallion's fee, the purchaser is liable to pay the additional fee, but if the replacing stallion's fee is less than the original fee, no monies will be refunded.
  - D. Since there is no fault on the part of the stallion or mare owner for these extenuating circum stances, the replaced stallion's get will be eligible to participate in the DPHCSB Futurity for the year of eligibility provided the owner pays the \$350 nomination fee.
3. The sale of the stallion service will begin November 1 of each year. The price is 60% of stallion fee posted. All sales are on a first come, first serve basis. All rules of the sale form and purchase contract will apply. There is a \$25.00 service charge added to each sale. See Doug Miller for details.
4. Any APHA, AQHA or JC stallion from any state maybe nominated for the DPHCSB Futurity . Only the get from participating stallions are eligible for the DPHCSB Futurity classes and any registered get may show in DPHCSB Futurity halter, longe line, and two year old pleasure classes. Florida bred classes will be for Paint gets foaled in, owned by, and shown by a Florida resident.
5. All horses must have original registration papers to show in futurity classes, or original facsimile copies from APHA. All futurity entries must be accompanied by a copy of the papers, with the original to be presented to the Show Secretary to receive a back number. No papers - No show. APHA breeding stocks are eligible for all Futurity and stakes classes.
6. All monies collected from the stallion service sales and nomination fees will be split between all DPHCSB Futurity classes.
7. The DPHC will retain 25% of the entry fees for expenses.

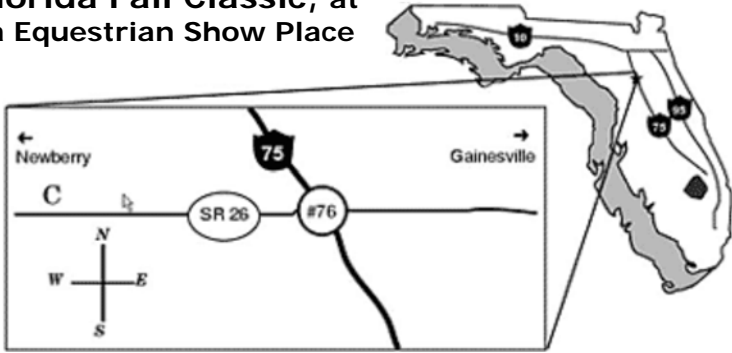
